"BTA Bill No. 157 otherwise known as, "An Act Ordaining the Promotion of Social Enterprises in the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM), establishing for the Purpose the Bangsamoro Resilient, Inclusive Social Enterprises (RISE) for Peace and Sustainable Development Program, Providing Incentives, Benefits and Appropriations therefor."

Significantly, for the oversight role, our office apart from overseeing the various ministries and offices in BARMM thru legislations, also actively participated in the deliberations of the 79.5B budget of BARMM for 2022. For almost 21 days, MP Maisara thru the Committee on Finance, Budget and Management of BTA participated in the scrutiny the 2022 Budget Expenditure Program of BARMM, and recommended several measures to improve governance and effective delivery of public goods and services to the Bangsamoro people by the BARMM government.

LEGISLATIVE ACCOMPLSIHMENTS



BILLS

In the last quarter of the year 2021, two (2) bills filed by the Office of MP Atty. Maisara Dandamun-Latiph were approved on second reading. They are as follows:

BTA-Bill No. 157	AN ACT ORDAINING THE PROMOTION OF SOCIAL ENTERPRISES IN THE BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO (BARMM), ESTABLISHING FOR THE PURPOSE THE BANGSAMORO RESILIENT, INCLUSIVE SOCIAL ENTERPRISES (RISE) FOR PEACE AND SUSTAINABLE DEVELOPMENT PROGRAM, PROIDING INCENTIVES, BENEFITS AND APPROPRIATIONS THEREFOR; and
BTA-Bill No. 71	AN ACT INSTITUTIONALIZING SUPPORT TO THE WELFARE AND CARE FOR ORHPAHNS BY ESTABLISHING BANGSAMORO ORPHANAGES IN THE REGION, AND PROVIDING FUNDS THEREFOR

SOCIAL ENTERPRISE

A social enterprise is a business with specific social objectives that serve its primary purpose. Social enterprises seek to maximize profits while maximizing benefits to society and the environment, and the profits are principally used to fund social programs. An advocate of social enterprise, MP Maisara seeks to introduce in the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) a social business that balances profits and benefits to society. As stated in the bill, the Parliament shall empower social stakeholders enterprise and establish mechanisms necessary for realizing the SEs potential and realizing full growth.

SPONSORSHIP SPEECH

Following the conclusion of the consultations for BTA-Bill No. 157 and its subsequent filing, MP Maisara delivered her sponsorship speech during the second reading of the bill on November 24, 2021 at the SKCC, BARMM Compound, as follows:

"It is enshrined in our Constitution to promote a just and dynamic social order that will ensure prosperity and independence of a nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all. Article XII, Section 1 further states that the goals of the national economy are a more equitable distribution of opportunities, income, and wealth;



a sustained increase in the amount of goods and services produced by the nation for the benefit of the people; and an expanding productivity as the key to raising the quality of life for all, especially the underprivileged.

Bringing it closer to home, the "Organic Law for the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM)" holds social justice as a general principle. As such, the Bangsamoro Government is required that every Filipino citizen in its territorial jurisdiction enjoys the provision of the basic necessities and equal opportunities in life. The Bangsamoro Government shall promote the effective use of economic resources and endeavor to attain economic development that facilitates growth and full employment, human development, and social justice.

As part of its vision to regional autonomy and patrimony, Art V. Sec 2 (k) of the Bangsamoro Organic Law (BOL) states that the Bangsamoro Government shall exercise its authority over matters on social enterprises.

Social enterprises are deemed part of the road to regional autonomy and patrimony --- this is an opportunity that could provide sustainable and important changes in our economy and poverty-reduction among disadvantaged sectors in the region particularly in the period of recovery from COVID-19 and internal strife.

What are social enterprises? Social enterprises refer to social missiondriven organizations with specific objectives that serve its primary purpose by maximizing profits while maximizing benefits to society and the environment to fund its social programs. However organized, these may be stock and non-stock corporations, sole proprietorships, partnerships or cooperatives but are reinvesting their profits to the social and environmental missions and/or for the stakeholders they support, usually the poor and marginalized.

This concept or model is intrinsic to us. Islam encourages entrepreneurship as an integral part of our faith. Muslims are khalifah and agents of trust of Allah who are responsible for generating prosperity and consider that doing business is a part of ibadah or good deed. To be successful in doing business, the most important thing is to be as useful as possible for the society and to live ethically in accordance with the characteristics of Allah.

However, to this day, while we are in need of such organizations, they are treated as traditional businesses experiencing disincentives as a result of an unfavorable policy environment. Government does not adequately recognize the social value these social enterprises create.

Without tailored support and without mainstreaming in the economy and in our poverty-reduction and peace efforts, social enterprises will experience challenges in scaling their growth and their social impact.

The Bangsamoro Social Enterprise Act of 2021 seeks to provide a nurturing environment for the development and growth of strong, proactive and innovative social enterprises as major vehicles for positive change in the Bangsamoro region. It proposes the formulation and adoption by the Bangsamoro government of the Bangsamoro Resilient and Inclusive Social Enterprises for Peace and Sustainable Development (RISE for Peace and Sustainable Development) built around the values of social justice, social equity, economic efficiency and peace.

The proposed measure mandates a registration system, various incentives and benefits for social enterprises. These include resources for capability building, tax exemptions, a diverse base of financing source, marketing, research and systems development support, and the preferential right of social enterprises to government procurement. Moreover, the bill mandates the creation of the Bangsamoro Social Enterprise Council which shall work with the Cooperatives and Social Enterprise Authority on social enterprise programs and services in the region.


Finally, the entrepreneur and entrepreneurship have a special place in Islam. It is based on interwoven pillars. The first is based on the definition of entrepreneurship, which is the pursuit of opportunities. The second pillar is socioeconomic or ethics. Entrepreneurship that is guided by a set of norms and values. And the third is religio-spiritual and links people to God with the ultimate objective of pleasing Allah. These pillars of entrepreneurial characteristics from Islamic perspective create wealth and value not for oneself but to serve others.

Thus, it is essential for us to enact a law that will empower social enterprises that are geared towards uplifting the conditions of the most vulnerable and marginalized Bangsamoro communities. These businesses for a purpose are contextually aligned to the Bangsamoro region and its people. By supporting social enterprises and enabling cooperation between the government and the citizenry, we can create a more inclusive and sustainable path in addressing the complex challenges of our time. This proposed measure seeks to ensure that this can be achieved.

With these, the passage of this bill is earnestly sought."

BANGSAMORO ORPHANAGE ACT OF 2020

Following the conclusion of the consultations conducted in various provinces of the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) for BTA-Bill No. 71 and its subsequent filing, MP Maisara delivered her sponsorship speech during the second reading of the bill on December 21, 2021 at the SKCC, BARMM Compound, as follows:



BTA BILL TO ESTABLISH BANGSAMORO ORPHANAGES

To institutionalize support for the welfare of orphans in the Bangsamoro region, Atty. Maisara Latiph filed a bill that seeks to establish a regional system for accredited orphanages.

SPONSORSHIP SPEECH

"Today, I have the honor to seek approval of Proposed Bill No. 71, entitled AN ACT INSTITUTIONALIZING SUPPORT TO THE WELFARE AND CARE FOR ORPHANS BY ESTABLISHING BANGSAMORO ORPHANAGES IN THE REGION, AND PROVIDING FUNDS THEREOF filed on November 9, 2020.

I am standing here today as a Member of Parliament, a Mother, a Moro, and an advocate for children's rights with an immense concern for the well-being of our future generation.

In Islam, an orphan is the child or the minor who, by the will of Allah, has no parents or has just one parent. In Islam, the absence of a father either by death or abandonment or any other reason results in the child becoming an orphan. The child remains an orphan till he/she reaches the age of maturity or puberty. Because orphans are minors, they are physically weak, disadvantaged in society, and often suffer from poverty. Many are children of shaheed, or martyrs in the service of the Moro revolutionary fronts. For a child who has lost a parent, life is filled with hardships. In the absence of early child and development support, the orphaned child is one of those most vulnerable to poverty, radicalization, and criminality. Some orphaned children are blessed by being adopted by their relatives, but some are not provided with enough care. Meanwhile, there are those supported by institutions, however in truth, only a few are accommodated due to limited resources.

The sad reality is that if foster parents, social workers, or institutions are not there to provide what they need, no one will. This is the time for the Government to step in. Under the principle of parents patriae, the Government should stand in as the parents and caregivers of the orphaned child.

As the new government raises the so-called "BARMM", we believe that every sector should have the opportunity to be heard. Orphans are among the most vulnerable sectors. On top of that, they do not have sufficient budget, programs, projects, and policies for them.

According to the research study by The Asia Foundation in 2020, entitled Children of War, there are currently no Department of Social Welfare and Development (DSWD) or MSSD -accredited orphanages or shelters in the Bangsamoro region, some reasons is that they did not meet the requirements given to them, that's why, many Muslim orphans are often sent to orphanages in Manila.

Moreover, Respondents across the region noted that being unattended, ignored, and unloved leaves orphans vulnerable to radicalization and co-option by violent extremist groups. Without proper assessment and processing of their emotions, orphans may grow up believing resolving issues through violence is normal.

This bill seeks to institutionalize support for the welfare and care of orphans in the Bangsamoro region by establishing a system of accredited Bangsamoro Orphanages within each province throughout the region which will help alleviate the condition of every orphan and to provide them with the opportunity to live a fulfilled life. Moreover, it seeks to create a system that will determine the qualified beneficiaries and to monitor and evaluate the proper provision of this Act.

It has been months of efforts from our office to come up with this Bill. Our office conducted series of CARE FOR ORPHANS PUBLIC CONSULTATIONS IN AID OF LEGISLATIONS IN THE WHOLE REGION in partnership with The Asia Foundation. Our first consultations held in Lanao is on March 20, 2021, in Maguindanao and Cotabato on May 31, 2021, and to the provinces of Basilan, Sulu, Tawi-Tawi in the months of June and July. The consultations focused on the various issues and concerns of orphans, as well as the stakeholders who took care of them, and participated by different sectors, stakeholders, individuals, institutions, offices/ministries, and various organizations.

They provided inputs and recommendations addressed to the Bangsamoro Government, and to our Proposed BTA Parliament Bill No. 71, or the "Bangsamoro Orphanage Act 2020", where the participants gave their comments, inputs, and recommendations for the improvement of the bill. Our participants and many stakeholders signed the manifestation of support for the immediate passage of this Bill.

Some of the major issues and concerns that were raised from these consultations is that there was no concrete data about orphans in the region; there are also challenges with respect to the subpar standard of centers (Toril/Madrasa Institutions);

Limited financial support and assistance to the orphans, including homebased, center-based, and displaced orphans;

Lack of access to education and health services; Lack of support and supervision among the orphans in the home-based and center-based institutions (Toril learning schools and Madrasah); Vulnerable to recruitment and radicalization; and Issues on Security and Justice, Prone to Abuse.

I will now highlight the main features that we proposed from the Bill: •There is hereby created a system which shall lead the creation of a credible mechanism to determine the eligible beneficiaries and shall create the appropriate model for the orphanages in the respective community. It is also its mandate to come up with a comprehensive monitoring system to address the needs of orphaned minors in the respective community. It shall include, but not be limited to, coming up with updated data on the number, location, and personal profile of orphaned minors in their respective communities, developing the appropriate models of orphanages in the respective community, and monitoring the orphaned minors in the orphanages.

- The Bill also seeks to develop and create Comprehensive Support Program that is institutionalized as a mechanism to provide social welfare and care for orphans in the orphanages by the Bangsamoro Government through its implementing agencies. The programs shall include but is not limited to: (i) Basic needs; (ii) Physical safety and security; (iii) Socio-economic needs; (iv) Educational needs; (v) Emotional and spiritual needs, and (vi) Access to justice.
- The Bill includes the constituent LGUs in the Bangsamoro Region are mandated to develop a monitoring and evaluating system over the orphanages found within their jurisdiction, and to assist them with accreditation.
- There shall be a managing committee in charge of the management of the established Bangsamoro Orphanages and shall requires program requirements and transparency.

Mr. Speaker and Members of Parliament,

To pass this bill also means to implement the mandate of Bangsamoro Organic Law. It is hereby declared the policy of the Bangsamoro Government to respect, protect and promote the rights of children, especially orphans of tender age. They shall be protected from exploitation, abuse, or discrimination. Their education and development, both physical and mental, shall be protected from exploitation, abuse, or discrimination. Their education and development, both physical and mental shall be fully addressed under Section 14, Article IX of Republic Act 11054.

Bangsamoro policies and programs shall take into utmost consideration the best interest of children, and promote and protect the rights of children, youth, and adolescents, including their survival and development. The Bangsamoro Government and its constituent local government units shall provide for adequate funding and effective mechanisms for the implementation of this policy.

Building orphanage centers (Baytul Yatim) will help alleviate the condition of every orphan. Orphans are often sent to this institution as a way of relieving a family with very little income or limited capacity to meet the needs of the child. Orphans in orphanages should be given a safe environment to grow, with a good place to sleep, adequate food and proper schooling, and also visited their families often, this way to help them grasp their rights as individuals. By institutionalizing to build orphanages that are supported by the Bangsamoro Government, we will have more impact on the lives of these orphaned children and reach those more in providing services with quality care.

We all know how much our orphans are being valued and cared by our religion. Besides, our Prophet Mohammad (S.A.W) is an orphan himself, and the topic on orphans has been mentioned for over twenty times in the Qur'an and is also signified by the Hadith and Sunnah of the Prophet (S.A.W) countlessly.

As per the Hadith of the Prophet Mohammad (S.A.W) mentioned in Saheeh Al-Bukhari: "I and the caretaker of the Orphan will enter Paradise together like this, (raising his forefinger and middle finger jointly, leaving no space in between.)"

When we help orphan children raised in a healthy and loving environment, they grow up to be responsible individual, and there will be less crime, less deprived children and less out-of-school children. Our children are the most valuable resource in our country and its best hope for the future, before they can be responsible and ideal youth, we need to guide and mold them in their early years to help them become the best version of their selves. Our children's future is worth every sacrifice; by helping them, we are helping our future.

It is for these reasons that the early approval of this bill is earnestly sought.

Mr. Speaker and Members of Parliament,

EVERY BANGSAMORO CHILD DESERVES TO BE PROTECTED. IT IS FINALLY TIME TO ESTABLISH ORPHANAGES IN THE BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO (BARMM) AND TO PROVIDE SUPPORT TO OUR INSTITUTIONS HOUSING ORPHANS ESPECIALLY FOR OUR CHILDREN OF SHAHEED OR MARTYRS IN THE SERVICE OF THE MORO REVOLUTIONARY FRONTS.

AND SO, I HUMBLY RECOMMEND TO THE BANGSAMORO TRANSITION AUTHORITY TO ADOPT THIS BILL AND TO SUPPORT THE QUICK PASSAGE OF BTA PARLIAMENT NO. 71 OR THE BANGSAMORO ORPHANAGE ACT 2020, FOR THE SAKE OF OUR CHILDREN AND ORPHANS IN THE BARMM.

BUDGET HEARING:

BANGSAMORO EXPENDITURE PROGRAM 2022

SUB-COMMITTEE B

As the Vice-Chairperson of the Sub-Committee B of the Committee on Finance, Budget, and Management, MP Atty. Maisara Dandamun-Latiph presided the budget hearings which were conducted for the deliberations of the proposed budget of the Bangsamoro Attorney-General's Office (BAGO); Ministry of Social Services and Development (MSSD); Bangsamoro Women Commission (BWC); and Development Academy of the Bangsamoro (DAB).

Following the conclusion of the budget hearings for the government agencies under Sub-Committee B on December 3, 2021, MP Maisara presented the reports for the proposed budget for the Fiscal Year 2022 of the abovementioned agencies before the Committee on Finance, Budget, and Management (Mother Committee) on December 10-11, 2021.

First among the reports deliberated upon were the proposed 2022 budget of the Bangsamoro Attorney-General's Office (BAGO) and the Ministry of Social Services and Development.

BAGO is the chief legal counsel of the Bangsamoro Government which renders legal opinions in legal matters referred to it. As contained in the Bangsamoro Expenditure Program (BEP), it has a proposed budget amounting to P43,053,631.14 with a proposed additional budget for personal services of P1,613,947.52. On the other hand, MSSD had a proposed budget amounting to P2,699,819,361.91 with a proposed increased of P418,327,568.80 intended for Bahay Pag-Asa, Home for the Aged, and Orphanage Centers.



The budget of the agencies as proposed by the Sub-Committee B presided by MP Maisara were all approved by the Mother Committee and their requests for additional budget were respectively referred to a Technical Working Group (TWG) which was tasked to resolve issues surrounding the request for increases and to determine whether increases should be granted or denied and make a recommendation thereupon to the Mother Committee. MP Maisara was appointed by the Chairperson of the Mother Committee as member of the Technical Working Group (TWG).

On December 22, the Committee on Finance. Budget, and Management deliberated upon the report of the technical working group, and on December 23, after a lengthy, exhaustive, and emotional deliberation. the Committee the approved at committee level the Bangsamoro Expenditure Program for 2022 and decided to submit its final report to the Parliament for deliberation and consideration.



BANGSAMORO EXPENDITURE PROGRAM FOR 2022

The Bangsamoro Parliament approved the 2022 Bangsamoro Expenditure Program amounting to P79.862 Billion on December 28, 2021 in a special session with 59-0-0 votes. They also approved a measure extending the availability of the 2020 and 2021 General Appropriations Act of the Bangsamoro until December 2022 with 46-0-4 votes and abstentions respectively.



BANGSAMORO LABOR AND EMPLOYMENT CODE OF 2022

COMMITTEE ON LABOR AND EMPLOYMENT

As the Vice-Chairperson of the Committee on Labor and Employment, MP Maisara was assigned to come up and submit a draft of the proposed Bangsamoro Labor Code and Employment during the 3rd quarter of 2021.

After months of writing, the draft of MP Maisara was submitted to the Committee which subsequently organized a meeting for its approval. Below is the sequence of events that transpired after the submission and presentation of the draft:



OCTOBER 14, 2021

The draft was presented by MP Maisara and was approved by the Committee subject to the incorporation of the provisions that will be submitted by the other members of the Committee.



NOVEMBER 2-5, 2021

Following the approval of the draft at the committee level, a write-shop was conducted by the Ministry of Labor and Employment to consolidate the provisions submitted by the members of the Committee on Labor and Employment. Represented by Atty. Abduljabbar Guro, the Office of MP Maisara was responsible for the formulation of the provisions creating the various tribunals and offices necessary for the administration of the Bangsamoro Labor Code. Moreover, the Office of MP Maisara provided for the jurisdictions of the tribunals and various government agencies created by the Code as well as their relationship with one another.


The consolidation was followed by a series of consultation wherein stakeholders from the labor, management, academe, and various sectors were invited as resource persons. The Office of MP Atty. Maisara Dandamun-Latiph presented the organizational structure of the labor tribunals as well as the new institutions to be created along with the corresponding proposed provisions.





The Office of MP Maisara participated in the write-shop on the finalization of the Bangamoro Labor Code in Davao City. During the event, various lawyers from the Bangsamoro Government were invited. Represented by Atty. Guro, the Office of MP Maisara defended the provisions which were originally adopted at the committee level as well as the proposals of other committee members including the issue of ending contractualization.





DECEMBER 16-17, 2021

The Office of MP Maisara participated in a (2) two-day legal scrubbing session on Bangsamoro Labor Code in order to finetune the provisions of the proposed Code.



DECEMBER 21, 2021

Represented by her Chief of Staff, the Office of MP Maisara delivered a closing remark during the presentation of the final draft of the Bangsamoro Lagor and Employment Code of 2022. Representatives from various sectors were present including those from the International Labor Organization, Centre for Humanitarian Dialogue, and Members of the Parliament, among others.in the program organized by the Ministry of Labor and Employment.



DECEMBER 24, 2021

The final draft of the Bangsamoro Labor and Employment Code of 2022 was presented to the Committee on Labor and Employment. The members of the committee subsequently approved it and agreed that it will be endorsed and submitted to the Cabinet. The Code is among the priority legislations of the Government of the Day.







TURN-OVER OF SIYAP KO KAPAGANAD PROGRAM

On October 22, 2021, the Office of Member of Parliament Atty. Maisara Dandamun-Latiph turned-over the Siyap Ko Kapagand Program to the (3) schools division of Lanao del Sur and Marawi City.

It is a program spearheaded by the Member of Parliament Atty. Maisara Dandamun-Latiph in partnership with Lanao del Sur I Schools Division headed by Dr. Sahanee Sumagayan, Lanao del Sur II Schools Division headed by Dr. Rubina Macabunar, and Marawi City Schools Division headed by Dr. Zenaida Unte.





According to the Bangsamoro Women Commission, there were 71 cases of VAWC in the region from January to October 2021. 70 of these incidents happened in Maguindanao province with 34 cases on violence against women, 1 case of rape, and 36 violence against children. Of the 36 incidents of violence against children, 22 were rape cases.



BTA-Bill No. 32 seeks to create the Ranao Development Authority as the agency that will be the lead institution to manage the development, utilization and preservation of Lake Lanao. The Authority shall create the framework and plan designed to protect, conserve, rehabilitate and develop the lake.

The discussion highlighted the presentation of the summary report during the Siyap Ko Ranaw Consultation in Aid of Legislation conducted last July 3, 2021. Among the issues and concerns mentioned are Endemic Cyprinid Species, Watershed Deforestation, Solid Waste Management, Health Risks and Water Pollution.

It is an advocacy-based video campaign production for children which aimed to feature, showcase, and inspire others the need to promote children's rights. This also aimed to recognize the working initiatives/ advocacy of individuals/ organization in Lanao del sur in advocating Children's rights and welfare relevant to the Children's Month Theme 2021.

On the first week of November, this program was launched via MP Maisara Dandamun-Latiph Official Facebook Page.

The mechanics of the selection are as follows:

- Video Entry must not be less than three minutes and should not go beyond 7 minutes;
- Video Entry must be relevant to the Children Month's theme 2021: "New Normal na Walang Iwanan: Karapatan ng Bawat Bata Ating Tutukan!";
- This is open to individuals/organizations in Lanao, and Marawi City;
- Entry that uses either Filipino/Maranaw Language must include English subtitles;
- The video should highlight and showcase the need to promote the children's rights by working together, and the working initiatives/advocacy (programs, activities, seminars/workshops, enterprise, etc.) of the individual proponent/organization in advocating for children's rights and welfare;



- The video might include the challenges of the children in a community, and the proposed solutions/recommendations, or the ongoing initiatives of the proponent/s that would address the challenges of the children in their community;
- Should there be children (17 years old and below) casted and featured in the video, there shall be a consent or waiver signed by parents/guardian that allowing them to include in the video;



TRAINING ON SOAP MAKING DISHWASHING LIQUID

On 9th of December 2021, the Office of Member of the Parliament Atty. Maisara Dandamun-Partnership with **TFSDA** Latiph in Muntiparlastapat District Training and Assessment Center implemented Livelihood Training on Soap Making Dishwashing Liquid for twenty (20) participants. Trainees of the said training are in and out-of-school youth, and unemployed Bangsamoro People residing in Metro Manila. This training aimed to provide a venue for the participants to engage with others and make a sustainable income to support their families. They were also provided tool kit to start their own liquid soap business.

TRAINING ON PROCESSING HALAL CHICKEN LONGANISSA

On October 28, 2021, the Office of Member of the Parliament Atty. Maisara Dandamun-Latiph in Partnership with TESDA-National Capital Region (NCR) conducted Livelihood Training for (20) participants. LIVELIHOOD TRAINING FOR THE WOMEN IN MARAWI CITY DUMPSITE

Lanao del Sur dumpsite is located in Papandayan Caniogan, Marawi City. More than a hundred families currently reside in this place. Poverty, lack of sanitation, and unhealthy environment are among the observations that can be seen in the community. Children playing in the dumpsite can also be seen in Caniogan Papandayan.

Despite the poverty that they are currently experiencing, they keep on having determination and courage to sustain their day-to-day life with a simple yet contented lives. Most of the people of the dumpsite depend on tricycle driving, but due to the pandemic, it has affected them. Waste Trade is also one of the major income sources of the people of Caniogan Marawi City. Risky, but they still continuously do this to sustain their basic needs such as food and others.

Education is quite hard to access by the children of dumpsite. This is due to financial constraints being experienced by their parents. But still some of the children there can access education in different public schools and Madrasahs.

To reduce the unemployability being encountered by the people of Marawi City dumpsite, MP Maisara has initiated the Siyap ko mga: A Training on Sustainable Livelihood Development Program. This is categorized into two skills training such as Bread and Pastry Training, and Dressmaking Training. This program is a partnership program of the Office of Member of Parliament Atty. Maisara C. Dandamun-Latiph, Ministry of Basic, Higher, and Technical Education (MBHTE) through its TESD, Bangsamoro Women Commission-Lanao del Sur, and Ministry of Social Services and Development.

Beneficiaries are vulnerable women residing in dumpsite, Caniogan Marawi City. There were 25 trainees for the Bread and Pastry Training and another 25 trainees for the dressmaking training.

"Our Office is continuing towards promoting interventions intended to uplift the marginalize and the less privilege of the society especially here in Lanao del Sur and Marawi City. Our approach is towards Sustainable Economic and Social Empowerment of the target partners/beneficiaries.", said by MP Maisara

Siyap Ko Mga Bae aims to strengthen the skills of the community in giving a training; help educate the mothers find other ways of dress-making and entrepreneurship; and making a living to support their family through this program; uplift the economic stability of the residents in the area; engage the women to more productive interventions; improving peace and stability and increasing resiliency; promote inclusive and broad-based economic growth; encouraging sustainable development; and provide some for the residents learn different techniques and strategies in dress-making, entrepreneurship, production and



marketing of the products that can help them in aid of legislation.

Part also of the training is the provision of start-up kit for the women trainees to sustain the skills they acquired from the training.

2021 marks the 21st anniversary of the adaptation of United Nation Security Council Resolution 1325 on Women, Peace, and Security, a ground-breaking resolution that was spearheaded by women leaders. advocate, and organization. It is the first resolution that recognized women's leadership to achieve international peace and security and their contributions to conflict prevention, peacekeeping, conflict resolution, and peacebuilding.
