CARE FOR ORPHANS PUBLIC CONSULTATIONS ALL OVER THE REGION



EXECUTIVE SUMMARY

Orphans are considered to be one of the most vulnerable members of the society. Without parent/s, a child could face varying degrees of struggle. Without the love and care provided by parents, their life is filled with hardships. However, with proper support from the government along with the legal guardians and the community, institutions catering to the needs of the orphans can be built.

One of the key concerns identified by our office is how there are no accredited orphanages in the BARMM. This is also in the research study titled: "Children of War: A Rapid Needs Assessment of Orphans in Muslim Mindanao" that was supported by The Asia Foundation. In response to this, our office filed the BTA-Bill No. 71, the "Bangsamoro Orphanage Act 2020" which would establish and regulate orphanages within the region.

As the new government raises the so-called "BARMM". every sector should have the opportunity to be heard in order for their concerns to be known and addressed. **Participative** and informative consultations are necessary for the crafting of responsive legislations.

The Office of MP Atty. Maisara C. Dandamun-Latiph in partnership with "The Asia Foundation" and "The Australian Aid" conducted a series of "CARE FOR ORPHANS **PUBLIC CONSULTATION** IN AID OF LEGISLATION" in the province of Lanao, Maguindanao and Cotabato, Basilan, Sulu, and Tawi-Tawi.

The consultations focused on the various issues and concerns of orphans, as well as the stakeholders who took care of them, and shall be participated by different sectors, stakeholders, individuals, institutions, offices/ministries and various organizations.

The participants and the stakeholders provided inputs and recommendations addressed to the Bangsamoro Government. The first part of the discussion shall be the presentation of the "Children of War: A Rapid Needs Assessment of Orphans in Muslim Mindanao", a research study that was supported by The Asia Foundation.

The second part is the presentation of Proposed BTA-Parliament Bill No. 71, or the "Bangsamoro Orphanage Act 2020", to be followed by open discussions where the participants can give their comments, inputs, and recommendations for the improvement of the bill.

The last part of the session is the signing of the manifestation of support for the Bangsamoro Orphanage Act 2020 from the attendees, and stakeholders.

On March 20, 2021, the first consultation was held at the MSU-IPDM, Marawi City, Lanao del Sur, and it was attended by forty (40) partners, and different stakeholders representing sectors, organizations/institutions such as Sadaga Tatap, Save The Children, United Imam Of The Philippines, Philippine Humanitarian Care (Philcare), Hijab For A Cause, Bridge Of Hope, Adopt A Morit Program, Wamy (World Assembly Of Muslim Youth)- Philippines, Jamiatul Waqf Al-Filibbin, Saksi Orphanage Learning Center, Al Majlisol A'laa Linnisa El-Muslimat Fil-Filibbin, Inc., Markadz Shabab Fil Filibbin, Darul-Aitam Litahfidhil Our'an, Al-Faui Al-Imanie Philippines, Zaid Bin Thabit, King Faisal Center For Islamic Arabic & Asian Studies-Msu Main, Al-Muiadilah Development Foundation, Inc. (Amdf), Mahad Angovao Al-Islamie, Bustanul Muslimin Wal Muslimat, Jamiatu Muslim Mindanao (Jmm), Madrasah Al-Hikmah, Malavsia Al-Mustafa International University, Tehran, Peace Youth Movement, Ranao Charitable Society and some offices and agencies such as MSSD-B, PSWDO, CSWDO, MILG- LGOO II/GAD Focal Person.



On May 31, 2021, our second consultation held at Diamond Hall, EM Manor Hotel, Cotabato City with a total of twenty-three (23) partners, and stakeholders coming from different offices/institutions such as Markadj Nor, Markadj Badria, Markadj Abdul Rahman, Markadj Al-Arradz, Markadj Al-Qaadie, Darol Gale, Markadj Monera, Madrasah Barakah, Save the Children, Bangsamoro Emergency Action Team (BEAT), Kutawato City Arabic Students Association (KCASA), United Muslim Youth Organisation (UMYO), and a representative from Ministry of Basic Higher and Technical Education (MBHTE), Bangsamoro Women Commission (BWC), Ministry of Social Services and Development, STI Cotabato, and Office of MP Bainon Karon.

On June 27, 2021, our third consultation held at RnR Hotel, Sanga-Sanga, Bongao, Tawi-Tawi.

This has been attended by twenty-seven (27) participants coming from different government offices/ministries, institutions/madrasa, religious academe sector, CSOs/Non-government organization, and other concerned community leaders. Among the Offices/Organizations that were present: Notre Dame of Bongao, Mahardika Institute of Technology, Tawi-Tawi Regional Agricultural College, PAO, Office of Provincial Mufti, MAJLIS, Qudwatun Nisail Muslimat, Sali Nudjang Foundation, Inc., Mahad Dar Al-Asar, Inc., Mahad Tawi-Tawi Al-Arabie Al-Islamie, TFLF/Child Fund Philippines, AMBUH-INAH, Tawi-Tawi Provincial Women Council, PSWO, PLGU GAD Tawi-Tawi, MBHTE-BARMM Tawi-Tawi Division, Office of MILG Provincial Director, BCW-BARMM, MSU-TCTO, and Office of Provincial Administrator Tawi-Tawi.



On June 29, 2021, our fourth consultation held at Formation Center, 10cp Garcia Isabela City, Basilan. Nineteen (19) attendees were able to participate in the said consultation. They represent different Organizations/Institutions, and Offices/Ministries such as: Basilan State College, Office of MP Hatimil Hasan, Lamitan City Madaris, Ulama Supreme Council, Mahad Sumisip Al-Arabie Al-Islamie, Makamus Sar-Ih, Magpatulahad Basilan, Kalukbanan Kasambuhan Organization, CBCS Basilan, Save the Children, MSSD Basilan, Ministry of Health, Basilan School Division, Office of MP Faiz S. Alauddin, Yakan City Committee MILF, Hafizul Qur-an, Addirasatul Islamia CSO, Madrasah Jehra and BWIF.

On July 1, 2021, our fifth consultation held at Notre Dame of Jolo College Compound Main Campus, Gandasuli Road, Jolo, Sulu. Eighteen (18) participants came from different offices and Organizations that were able to attend such as Sulu State College, Notre Dame of Jolo College, Mahad Mandangan Academic, Madrasa Tarbiya, SUCPD, Matawkasi Inc., TSS CBCS, MSSD, MBHTE, IPHOSulu, Bangsamoro Women Office, and MILG, and BYC.

Some of the major issues and concerns that were raised from these consultations is that there was no concrete data about orphans in the region; there are also challenges with respect to the subpar standard of centers (Toril/Madrasa Institutions); limited financial support and assistance to the orphans, including home-based, center-based, and displaced orphans; lack of access to education and health services; lack of support and supervision among the orphans in the home-based and center-based institutions (Toril learning schools and Madrasah); vulnerable to recruitment and radicalization; and Issues on Security and Justice, Prone to Abuse.

Some of the recommendations and suggestions that were highlighted from these consultations, including the research study "Children of War: A Rapid Needs Assessment of Orphans in Muslim Mindanao" that was supported by the Asia Foundation:



Establish and build a comprehensive database and monitoring system for orphans, including home-based, center-based, and displaced orphans. This system is necessary for the smooth implementation of responsive and effective programs catered to orphans. There should be collaboration among the BLGUs, LGUs, the MSSD, and the Regional Government (Bangsamoro Government):



Declaration of orphans as wards of the state and allowing them to enjoy free government services such as shelter, subsistence, education (such as scholarships from the Ministry of Basic, Higher, and Technical Education), livelihood support and health services. They may be given IDs along with widows, similar to those given to Senior Citizens, so that they can avail of discounts and benefits:



Design a holistic and inclusive comprehensive support program for both widows and orphans.





The following should be considered:



FINANCIAL ASSISTANCE AND SUPPORT



FOOD AND NUTRITION

Food security: Orphan children should have sufficient food to sustain an active and healthy life at all times.

Nutrition and growth: Orphan children should be monitored if they are growing well.



SHELTER AND CARE

Shelter: The child should have shelter that is adequate, sustainable, and safe both in home -based and center - based institutions.

Care: The child has at least one adult/guardian who provides consistent love and support.



SAFETY AND PROTECTION

- 1. Protection from abuse and exploitation: The child is safe from any abuse, neglect, or exploitation.
- 2. Safe from recruitment and radicalization.
- 3. Legal protection: The child has access to legal protection services as needed.



HEALTH SERVICES AND WELLNESS

1. The child should be monitored and has free access to health services.



PSYCHOSOCIAL SUPPORT

- 1. Emotional health: The child is happy and content and has a generally positive attitude.
- 2. Social interaction: The child is cooperative and enjoys participating in activities with other children and adults



EDUCATIONAL NEEDS AND VOCATIONAL TRAINING

- 1. Provide scholarships and education packages support such as allowances for orphans both in home -based and center -based institutions.
- Balanced curriculum to be taught in Torils and for such institutions to be provided with livelihood training by TESDA.



LIVELIHOOD PROGRAM AND ENTREPRENEURIAL SKILLS TRAINING

1. Provide capital seeds for business enterprise or job opportunities for widows/guardians to improve living conditions of home-based orphans.



Recommending the Bangsamoro Transition Authority (BTA) to pass a law creating and institutionalizing *Zakat* within the Bangsamoro territories created pursuant to the Bangsamoro Organic Law. This includes the possible creation of a *Baytal Mal* (House of Wealth), which is a public institution responsible for the collection and implementation of the *Zakat system* among Muslims;



The Bangsamoro Government is also recommended to create Islamic instruments, such as endowment (Waqf) to receive gifts and donation for orphans, and to strengthen Islamic Finance in the region;



To conduct a research book related to orphan protection;



To educate parent/guardians in the teachings of Islam by conducting symposia, conferences, seminars on Child and Orphan protection and consultations in collaboration with the Ulama, Traditional leaders, LGUs, and other institutions;



Provide support and assist in accreditation to the existing orphanages or center -based such as Markadz, Toril, and Madaris;



The BLGU IRA should have an allocation in their budget for the orphans and orphanages in their own respective communities;



The Bangsamoro Government should provide support, financial or administrative, to accredited organizations or institutions whose principal function are assisting, taking care of, and supervising the well-being of young orphans;

Establishment of optional alternative housing (permanent or temporary) for orphans which are gender-sensitive. Considering the context of the Bangsamoro region, there should be institutions which cater specifically to female orphans managed solely by women;

For neglected and abandoned children, there should be a ruling from Shari'ah Courts determining their status as neglected or abandoned so that despite both parents living, since they can no longer be supported by their parents, they may be considered as orphans and be able to avail the benefits of programs for orphans.

There is also a proposal in each barangay to have Barangay Social Worker that is also focused on the data gathering for orphans, etc., and to oversee the status quo of the orphan, and vulnerable children in barangay.

As a Muslim, it is our duty to protect others from any kind of harm and help those who are in need such as orphans. Islam has laid great importance on helping the needy and has few reminders regarding the reward for helping orphans.

As per the Hadith of the Prophet Mohammad (S.A.W) mentioned in Saheeh Al-Bukhari:

"I and the caretaker of the Orphan will enter Paradise together like this, (raising his forefinger and middle finger jointly, leaving no space in between.)"

CHILDREN OF WAR: A RAPID NEEDS ASSESSMENT OF ORPHANS IN MUSLIM MINDANAO

This study was one of the references used in crafting of the bill "Bangsamoro Orphanage Act 2020".

This is supported by The Asia Foundation and The Australian Aid. The executive summary of the study is as follows (reference: https://bit.ly/Children of War Study):

"This report summarizes findings from a rapid assessment of the status of orphans—called in the vernacular as يمتي/yatim(Arabic) or ماتيلاً /al-aytām (Arabic), i'lu (Tausug), ilo (Bisaya, Mranaw, Maguindanaon), or ulila (Tagalog)—who have lost at least one parent from the wars in Mindanao in the last decade (2009-2019).

Many are children of *shaheed*, or martyrs in the service of the Moro revolutionary fronts, but the study also covers civilians who were killed in skirmishes and other major incidents such as the Marawi crisis.

Primary data collection was conducted from April to September 2019.

A total of 273 respondents were interviewed across 34 municipalities in seven (7) provinces, focusing on three broad catchment areas in the Bangsamoro region: Central Mindanao (Maguindanao and North Cotabato), the island provinces (Basilan and Sulu), and Ranaw region (Lanao del Sur, Lanao del Norte, and spillover areas in Northern Mindanao).

Due to the cultural definition of orphan-hood that is defined on the passing of the father, data was also collected on the plight of war widows.

The study also covers case studies on the orphans of Marawi's missing and disappeared such as the 2000 All-Out War, 2015 Mamasapano crisis, 2013 Zamboanga Siege, orphan sub-cells of the Abu Sayyaf Group, as well as selected best practices.

Given time and resource limitations, the study does not claim statistical representation; instead, this is a rapid assessment of the experiences and needs of orphans as a precursor to a larger and more systematic profiling and programming process.



MAJOR FINDINGS





- There are no official figures on the number of orphans affected by the wars in Mindanao. This reflects the general lack of service facilities for abandoned, neglected, and orphaned children in the Philippines, particularly those in the Bangsamoro. An unofficial database held by the MILF's Social Welfare Committee (SWC) reportedly has a list of 8,182 orphans covering 26 out of 47 revolutionary 'provinces' as of April 2019, while the MILF's Bangsamoro Islamic Women Auxiliary Brigade (BIWAB) is working on a partial list with just over 500 widows and a similar number of orphans as of January 2020. MNLF records largely cover only elite fighters (e.g. Top 90 and Top 300).
- Orphans are broadly defined as children who have lost at least one parent, particularly the father. Many are children of shaheed, but this study also covers the orphans of civilians killed in other major violent events. Orphans can be defined by type of parent lost, age, type of dwelling, and type of incident in which their parent was lost. Due to the cyclical nature of conflict in the Bangsamoro, shaheed status is often defined by communities not only as a result of death in combat but also as a result of displacement.



 When possible, orphans are supported by the family network. Support institutions (both home-based and in-center) also exist to provide assistance, often in the form of sadaqah (voluntary giving or charity) or zakat (tithing). However, most respondents only receive support from extended family members or support institutions for the first year; after two or three years, this support declines.



• There are no DSWD-accredited orphanages or shelters in the Bangsamoro. Instead, many Muslim orphans processed by DSWD in Mindanao are often sent to orphanages in Manila. Other private charitable organizations focused on children and orphans from the BARMM have arisen in areas with a sizeable Muslim diaspora, such as Maharlika Village in Taguig, Culiat in Quezon City, Quiapo, Manila, and Baguio City. These are used as educational hubs not only by ethnic Bangsamoro, but also by Balik-Islam, or reverts to Islam.



 Despite the extensive legal framework on children, there are no dedicated national programs for war orphans in the Philippines. Notable exceptions are programs of the AFP and PNP that serve widows and orphans of fallen soldiers and servicemen under *Republic Act No.* 6963 s. 1990. Selected P/CVE programs (specifically in Basilan) are looking at support for orphans who are former child soldiers, but these are still at a pilot stage.



 Education is a primary need, incentive, and goal for most respondents, alongside access to jobs. However, respondents identified at least five common needs and aspirations of orphans that should be addressed by a comprehensive support program: (i) Physical safety and security; (ii) Socioeconomic needs; (iii) Educational needs; (iv) Emotional and spiritual needs, and (v) Access to justice.

- Service provision is complicated by ongoing conflict and displacement, rido (family feud), and economic uncertainty. Even for those who are put in a markadz (center), intermittent funding may result in orphans being sent away again, if the center runs out of money for food. Limited cases of bullying and maltreatment were also identified.
- In the absence of ample support, faith is a common coping mechanism amongst orphans.
 Many orphans also have a strong desire to uphold the name and legacy of their fathers as shaheed.
- Respondents across the region noted that being unattended, ignored, and unloved leaves orphans vulnerable to radicalization and co-option by violent extremist groups. There is a fine line between the kinds of motivations that may draw orphans to 'legitimate' non-state armed groups such as the MNLF and MILF and those that lead to recruitment by 'black flag'-inspired violent extremist groups. Without proper assessment and processing of their emotions, orphans may grow up believing resolving issues through violence is normal. Exposure to broader environments may help children."



A. ISSUES, STATUS, GAPS, AND CHALLENGES OF ORPHANS

Re-data Gathering and Monitoring: There is no uniform database for orphanages in BARMM. According to the representatives from MSSD, they have programs such as cash assistance and counselling for orphans. According to a representative from MSSD, there are some conflict between the MSSD and local government units such as the barangays since they had previously experienced harassment and threats. Thus, they believe they cannot rely on the data provided by the barangay chairman.

There was a barangay chairperson who had attended the consultation and gave his perspective from the Barangay Local Government Unit (BLGU). According to him, the collection of data from the BLGU was only for a short term. When it came to programs, the system is that slots are given to the barangay. Hence, there was no data gathered or if gathered, the data would be inaccurate. Thus, there was a recommendation for data gathering to be done by the MSSD in partnership with the BLGU by going house-to-house in order to develop an accurate and comprehensive baseline database of orphans per region.

Re-abuse: According to some representatives of NGOs, orphans also experience physical abuse, sexual abuse, and financial abuse. Orphans may be pressured into early or forced marriages. Orphans also experience being subjected to forced labor which takes them away from their classrooms thereby affecting their education.

Orphans in the BARMM may be categorized into three depending on where they reside: there are home-based orphans who stay with their closest relatives, center-based orphans who stay in institutions which act or orphanages like *torils*, and displaced orphans with no fixed residence.

There is a need for stringent regulation of institutions which act as orphanages in order to prevent abuses. Also, there is a need for strict monitoring of home-based orphans to ensure that they are not suffering any abuse in their homes. Finally, there is a need to identify displaced orphans and to place them in regulated orphanages, or reunite them with their closes relatives, and provide them with necessary support.

Re-standard of Facilities, Torils, and Education: Participants shared the disheartening situation of institutions which act as orphanages in the BARMM. Often private institutions or madrasahs act as orphanages. However, since there was no regulation, a lack of funding has caused such institutions to fall into disrepair. Many institutions housing orphans (center-based orphans) do not have working restrooms.



They do not have proper beds, so orphans would be forced to sleep on the cold floor with just a straw mat. Despite the fact that administrators of such institutions endeavor to feed their orphans three times a day. However, in most cases these provisions are insufficient due to lack of funding thereby affecting the health of orphans. Many orphans suffer malnutrition and are stunted. The participants compared the situations institutions in the BARMM compared to orphanages for Christians or outside the BARMM which are better off.

Lack of Financial Support to Home-based, Center-based, and displaced orphans:

The primary problem is financial support for maintenance of the orphanage/center facilities), necessities of (infrastructure and orphans (food, safe drinking water, etc.), allowance for orphans, and salary for administrators/teachers. There are challenges also that no concrete data in center-based institutions such as torils and madrasa in the region, no proper monitoring and evaluation, and lack of manual of operation.

Thus, there is also a recommendation of the appropriate ministry/offices to oversee the center-based institutions such as *torils/madrasa*. It was also recommended to include orphans in the Gender and Development Code, the passage of Children's Code, Inclusion of Orphans in BTA Bill No. 23 (IDPs), and tailoring the needs according to the UNCRC for Orphaned Children.

The participants strongly recommended for regulation and institutionalized support. Some participants shared observations about how there were some institutions who would present themselves as Madrasahs and Torils and ask for donations and yet there was no improvement in the facilities.

There were also some who presented themselves as torils, yet there were no qualified teachers; there were none of them who memorized the Qur'an and/or the institutions had not produced anyone who had memorized the Qur'an. The participants seek for regulation to prevent such exploitation.

In relation to torils and education, administrators from such torils seek training from the BARMM government on how to best manage their institutions. They seek administrative training, as well as psycho-social help and counselling for the orphans under their care. In terms of education, the participants were in favor of a more balanced education curriculum for orphans staying in toril. Among their observations is that often the financial support given to orphans (from local and overseas sources) end once the orphan turns eighteen (18). Hence, by that age, orphans should already have the skills to pursue further education or seek work. Although torils have produced many religious teachers who were orphans, they worry about the number orphans who do not know English, or other livelihood skills. Thus, the recommend for a balanced curriculum to be taught in torils and for such institutions to be provided with livelihood training by TESDA.

B. PROGRAMS BY THE BANGSAMORO GOVERNMENT

At the outset, there has to be a definition in the law on what is meant by orphans from an Islamic perspective or within the Bangsamoro context. There is a need to harmonize the different definitions of orphans because the definition shall be the parameter for gathering baseline data on orphans within the BARMM. The following are recommendations by the participants on the actions the Bangsamoro Government should take with respect to orphans within the region:

•Declaration of orphans as wards of the state and allowing them to enjoy free government services such as shelter, subsistence, education (such as scholarships from the Ministry of Basic, Higher, and Technical Education), livelihood support and health services. They may be given IDs along with widows, similar to those given to Senior Citizens, so that they can avail of discounts and benefits.

- Establishment of optional alternative housing (permanent or temporary) for orphans which are gender-sensitive. Considering the context of the Bangsamoro region, there should be institutions which cater specifically to female orphans managed solely by women. Some participants recommended the Dream House model being implemented in Bangladesh where all of the needs of orphans can already be satisfied: physical, educational, psycho-social, community development, among others.
- Monitoring the welfare of orphans at the care
 of their guardians (home-based orphans) to
 protect them from abuse, neglect and violence
 such as slavery, child labor, trafficking, early
 marriage, harassment and sexual violence. For
 home-based orphans, regular sustenance for
 their support can be given to the families who
 are taking care of them.
- For neglected and abandoned children, there should be a ruling from Shari'ah Courts determining their status as neglected or abandoned so that despite both parents living, since they can no longer be supported by their parents, they may be considered as orphans and be able to avail the benefits of programs for orphans.
- Institutionalizing or reviving the zakah (religious obligatory tax; one of the five pillars of Islam) system. Muslims would have the obligation to pay such tax and the proceedings would be devoted solely for Islamic purposes such as the support of Madrasahs and Orphanages and/or Torils or their counterparts, which are often failed to be supported by the government due to the prohibition of the use of public funds for religious purposes.
- Directing the appropriate ministries to assist in the accreditation process for the center-based institutions such as Torils and Madrasa.

C. RECOMMENDATIONS FOR BANGSAMORO ORPHANAGE ACT 2020 (BTA BILL 71)

The participants were largely in favor of the proposed Bangsamoro Orphanage Act, saying that it was already time for such an act to be The recommendations passed. of participants were that there should be an institutionalized regulatory and monitoring system in place which involved the government in multiple levels, from the local government unit until the regional Bangsamoro Government, so that programs for orphans at all levels can be institutionalized. For example, according to the Provincial Social Welfare Development Officer of Lanao del Sur, the Provincial Government does not have regular programs for orphans.

Apart from the MSSD, the Ministry of Basic, Higher, and Technical Education (MBHTE), Ministry of Interior and Local Government (MILG), Technical Education, Skills and Development Authority (TESDA) should also be actively involved in this framework in order to address the educational and livelihood needs of orphans. The MILG can mandate the monitoring of the standards of orphanages by each LGU.

A recommendation from the MILG Assistant Provincial Director of Lanao del Sur can be seriously considered. Although under the Local Government Code, 1% of the budget of LGUs should be devoted to socio-economic programs, such percentage can be raised, and similar to the 5% GAD budget, perhaps a 5% budget for orphanages can be legislated. Such budget would be devoted solely for programs for orphans and supporting orphanages or institutions which act as orphanages within each particular LGU.







The recommendations were already included in the body of the report and were based on the sentiments of the participants.

As of now, the Bangsamoro Orphanage Act 2020 is up for its second reading. Hereinafter, it shall be referred to the appropriate committees. There is a need to pass the Bangsamoro Orphanage Act in order for it to become a law.

With respect to *torils* or indigenous boarding schools, it is strongly recommended that this system of education is regulated and supported, and the first step in doing so would be to include them in the proposed Bangsamoro Education Code. If the Bangsamoro Government undertakes the responsibility of regulating and overseeing these institutions, and providing them the support they need whether through capacity-building, curriculum development, financial support, or administrative training, these institutions would no longer be vulnerable to be used as recruitment grounds for vulnerable youth, especially vulnerable orphans who have no parents who would otherwise guide them to a better path.



CONCLUSION

Prophet Muhammad (PBUH) himself was an orphan. Thus, the Qur'an and Shari'ah mandates the protection of orphans. The orphans' rights include physical aspect, intellectual aspect, and spiritual aspect. The Bangsamoro Government should be the instrument by which orphans' affirmed, rights are respected, protected, and promoted following the spirit of Moral Governance. Children are among the most vulnerable of our society. following the principle of parens patriae, it is the State, or in this case the Bangsamoro Government which has the power and responsibility to act as the legal guardian for people who are unable to care for themselves - including our orphans, neglected and abandoned children.

During the session, proposed BTA-Parliament Bill No. 71 or the Bangsamoro Orphanage Act 2020 filed by our office, was also introduced. Suggestions and recommendations were gathered from our invited stakeholders to improve the bill.

OBJECTIVE

METHODOLOGY

On April 7, 2020 when President Rodrigo Duterte extended the "Enhanced Community Quarantine (ECQ)" or lockdown for the entire Luzon until April 30 from its original date which was April 12, the province of Lanao Del Sur and Marawi City had also announced the extension of ECQ to April 30 as a precaution to prevent the spread of the 2019 Coronavirus Disease (COVID-19). This was due to the recommendation of the IATF (Inter-agency task force) in combating the COVID-19 and in few weeks ago,

Provincial Governor Hon. Bombit Alonto Adiong stated that many did not want the further extension of the lockdown because of the observance of Ramadhan. However. an extension was needed to prevent the number of PUIs from rising again.

While many were being affected by the said crisis especially during the observance of the noble month of Ramadhan, the vulnerable sectors such as orphans in toril (Islamic Orphanage) and to the stranded students/morits (Arabic Learners) were more challenged while observing the implementation of ECQ that they struggled to their everyday means.

In response to this, the Office of MP Atty. Dandamun-Latiph provided Ramadhan Package of goods (which include but are not limited to sacks of rice, groceries, boxes of canned goods/noodles, fresh fish and vegetables/spices) that were distributed on each targeted ten (10) madrasa/toril in the Saguiaran, Municipality of Binidavan. Marantao and Marawi City, including the stranded students/morits (Arabic learners) coming from different places who were stuck in Poona Marantao, Marawi City. Some of them were referred by the netizens and the community Leaders/volunteers that they need immediate help during this crisis.

"COVID-19 Tabang Program" is one of the programs that the office implemented in view of the COVID-19 crisis.

ORFUND YES TO SE PROGRAM

Social Enterprises are businesses with primarily social or environmental objectives.

Social enterprises are more likely to innovate and experiment. They are typically designed to fill the gap in existing services that cannot be provided by the public or private sectors.

Among the large number of individuals chasing financial freedom, there is growing minority of social entrepreneurs who are focused on solving some of the world's biggest problems.

Utilizing the latest technologies and innovations, they are driven to create an impact that will improve our lives and environment. Making money is not enough for them. They want to add meaningful value to our society.

Problem: The Philippines needs numerous social entrepreneurs with innovative solutions to the society's most pressing social problems in the areas such as lack of livelihood, social and environmental issues, and the calamity and challenges that Filipinos are encountering right now.

Funding is by far the biggest challenge for the social enterprises. Literature identified that most social enterprises failed to secure start-up capital.

Given that most of the social entrepreneurs are individual entities, it is therefore difficult to accumulate enough funds at the beginning.

OBJECTIVE

Twenty (20) youth orphans from Lanao del Sur and Marawi City participated in the two-day training program conducted by the office of MP Atty. Maisara C. Dandamun-Latiph in partnership with the Ministry of Trade, Investment, and Tourism (MTIT) and Save the Children dubbed as ORFUND YES TO SE PROGRAM-Basic Entrepreneurial Skills Training and Sustainable Livelihood Enterprise.

The Program aims to promote more Social Enterprise in the region, capacitate and train more young people in social enterprise; and will give start-up capital to the trainees for their business proposals.

PRIORITY BILL

BANGSAMORO ORPHANAGE ACT 2020

However, with proper support from the government along with the legal guardians and the community, institutions catering to the needs of the orphans can be built.

As the new government raises the so-called "BARMM", every sector should have the opportunity to be heard for their concerns to be known and be addressed. Participative and informative consultation are necessary for the crafting of responsive legislation.


The Office of MP Atty. Maisara Dandamun-Latiph conducted series of Care for Orphans Public Consultation in Aid of Legislation to obtain a better picture of the status of orphans and children all over the BARMM region.

We believe that through participative and informative consultations like these, we can improve our services, and address the concerns of orphans so that we can give them equitable solutions, programs, and opportunities.

One of the key concerns identified by our office is how there are no accredited orphanages in the BARMM.

In order to address this, our office filed BTA-Bill No. 71, the "Bangsamoro Orphanage Act 2020" which would establish and regulate orphanages within the region in order for the Bangsamoro Government to step in.

Under the principle of Parents Patriae, the Bangsamoro Government should stand in as the parents and caregivers of these vulnerable children. By building orphanages and supporting institutions housing orphans so that they can provide quality care, the Bangsamoro Government will have more impact on the lives of orphaned children.

KEY MESSAGES

A Greater Impact on Children

Children from the vulnerable groups are at risk of not meeting their rights to survival, protection and development. Indigenous people's children in geographically isolated and disadvantaged communities are deprived of access to government services & programs. Children affected by armed conflict are at risk of maiming, killing and abduction. They also experience disruption in schooling and live their young years caught in a quagmire of want and suffering and long for peace and hope for a better future. [Building Peace & Protecting Children in BARM/Mindanao, Save the Children, 2019]

RECOMMENDATIONS

- The MSSD and other concerned ministries shall strengthen to impose Republic Act 10821(The Children's Emergency Relief and Protection Act) that state the protection of children, especially in times of emergencies and natural disasters. Among RA 10821's important provisions are the following:
 - A comprehensive emergency program for children;
 - Establishment of evacuation centers, with child-friendly spaces:
 - Transitional shelters for orphaned, separated, and unaccompanied children;
 - Assurance of immediate delivery of basic necessities and services for children;
 - Strong measures to ensure safety and security of affected children;
 - · Delivery of health, medical and nutrition services for children;
 - Plan of action for prompt resumption of educational services for children;
 - Promotion of children's rights:

- Child-centered trainings for responders;
- Child protection training for responders.

JUSTIFICATION

"Respondents across the region noted that being unattended, ignored, and unloved leaves the children such as the orphans vulnerable to radicalization and cooptation by violent extremist groups. Without proper assessment and processing of their emotions, orphans may grow up believing resolving issues by violence is normal if they are unable to trust those around them, it may make the situation worse. Exposure to broader environments may help children discern what is radical or extreme from what is not." [Children of War: A Rapid Needs Assessment of Orphans in Muslim Mindanao, Asia Foundation, 2020]

EVIDENCE FOR ACTION

"Employing children as soldiers in any form of armed conflict is one of the worst forms of child labor, globally. During the Marawi Siege in 2017, a report stating that the Maute Group had recruited children as fighters jolted everyone. But this is not something new as there have been presented reports that the Abu Sayyaf Group (ASG), Bangsamoro Islamic Freedom Fighters (BIFF), and others USE CHILDREN as part of the group's operations (Bangsamoro Development Plan: Chapter 9 P#166)".

KEY MESSAGES

Many accredited organizations and institutions in Lanao engaged in social welfare activities such as programs and activities in aid of orphans and other services for the vulnerable sector especially in times of calamity, but due to their organizational limitations such as lack of opportunities, limited resources-both financial and human from one or both sides, they were unable to do so.

While it is the responsibility of the government to provide social programs to its citizens it is also incumbent to everyone to help. With proper collaboration and works amongst the accredited organizations/groups and institutions that provide social programs could make it more sustainable and be able to improve services and opportunities for the target beneficiaries.

RECOMMENDATIONS

The Bangsamoro government should include the support to the accredited organization or institutions whose principal function is assisting, taking care of and supervising the well-being of vulnerable children in difficult situations especially the young orphans.

JUSTIFICATION

According to Executive Order 292 (Administrative Code of 1987), Title XVI, Chapter I, Section 3, Powers and Functions, to accomplish its mandates and objectives, the Department of Social Welfare and Development shall accredit institutions and organizations engaged in social welfare activities and provide consultative and information services to them. The MSSD should include supporting the programs and activities of the accredited organization and institutions that engaged in social welfare programs to further widen its humanitarian activities most especially the Bangsamoro territories.

Some of the Lanao del Sur non-profit humanitarian organizations such as Philippine Humanitarian Care (PhilCare), Al-Ashdiqah Foundation of the Philippines, United Imam of the Philippines and Hijab for a Cause provide programs and activities for the orphans and underprivileged morits (Islamic Education Students). Some financial resources came from the private donors within and outside the country and some are from the members. As much as they want to increase more beneficiaries and activities, they were not able to do so because of organizational limitations, particular financial.



KEY MESSAGES

Orphaned children are often sent to the orphanages as a way of relieving a widow from the stress of providing for her family with very little income. Orphans in orphanages should be given a safe environment to grow, with a good place to sleep, adequate food and proper schooling, and also visited their families often. By supporting and helping these orphanages to make it better and provide quality care, we will have more impact on the lives of these children and reach more orphans with care.

RECOMMENDATIONS

Registration and Assessment of Child Development Centers/Child Development Workers (Internal Assessment) & Reproduction of Assessment tools is under the program of MSSD. It enhances the set of standards for the CDCs and CDWs for a more efficient and effective delivery of Child Development Service, and reproduction of the hard copy of the accreditation tool (assessment and accreditation).

This should include the identification of the existing orphanages or any shelter that cater the orphans so the program can assist them with accreditation and provide appropriate interventions and services for them.

JUSTIFICATION

Section 3 of RA No. 5416 of 1968 (Social Welfare Act of 1968) provides that the social welfare department is mandated to set standards and policies to insure effective implementation of public and private social welfare programs;

- Section 3 of RA No. 5416 of 1968 (Social Welfare Act of 1968) provides also that the social welfare department is mandated to accredit institutions and organizations, public and private, engaged in social welfare activity including the licensing of child caring and child placement institutions and provide consultative services thereto;
 - Section 26 of Chapter 10, Title XVI of Executive Order 292 (Administrative Code of 1987) provides that no foster home, day care center and other substitute parental arrangement shall operate unless it is first registered with and licensed by the social welfare department.

EVIDENCE FOR ACTION

According to the researchers from The Asia Foundation, there are no orphanages or shelters in the Bangsamoro that were accredited by the Department of Social Welfare and Development (DSWD). Instead, many Muslim orphans processed by DSWD in Mindanao are often sent to orphanages in Manila and other regions. [Children of War: A Rapid Needs Assessment of Orphans in Muslim Mindanao, published by Asia Foundation, 2020]

Some orphanages or shelters such as Toril that cater orphans in Lanao del sur could not afford to accredit their institutions because of long process and many requirements for accreditation. They also do not receive any assistance from government.

POLICY BRIEF ON ORPHANS AND CHILDREN: RECOMMENDATIONS FOR CHILDREN'S ACCESS TO INCLUSIVE AND QUALITY LEARNING AT ALL TIMES

"No Bangsamoro Child Left Behind." However, this pandemic highlights a stark divide: children's access to education for those who can afford it and those who cannot. For many children, school is a safe haven and a protective environment. However, the COVID-19 pandemic is shifting children's learning from school to the home setting.

Education is the most effective means to overcome poverty and empower individuals over the long term-horizon.

However, for families with poor and limited access to resources, education tends to be of less priority when their income is just enough for their daily subsistence.

There are at least 213 barangays in the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) wherein children do not have access to any learning facility. This problem is affecting over 45,000 primary school aged children.

The Ministry of Social Services and Development (MSSD) has a program for Educational Assistance for children of disadvantaged and other needy families.

This provides the beneficiaries, once a year, with the amount of Php 10,000 for 6,000 College beneficiaries, Php 1,500 for 10,000 High School beneficiaries and Php 1,000 for 15,000 Elementary School beneficiaries for the year 2020.

There is still a need to increase this educational assistance and give more scholarship grants to the disadvantaged children through a wide region.

While the Ministry of Basic, Higher and Technical Education (MBHTE) provides scholarship programs such as, Access to Higher and Modern Education Scholarship Program (AHME-SP) also known as the "Bangsamoro IQ Scholar", this shall only accommodate Senior High School and Alternative Leaning System graduates in the region. However, there is an additional need to ensure that children's right to learn is supported even in a household setting.

Sierra Paraan, Basic Education Advisor of Save the Children Philippines, emphasized the importance of providing support to parents, caregivers, and elder siblings in the effective implementation of adaptive learning methods.



As provided in Republic Act No. 10533, schools and learning institutions shall continue to deliver education services that are "relevant to the needs of the people, the country and the society-at-large" in a manner that is appropriate, feasible and compliant to the minimum health and safety standards and directives from the BARMM-IATF, MOH, and other proper authorities.

Given the current context and until the situation improves, home-based or distance learning shall be the preferred modality.

However, face-to-face learning in school and other training centers may be employed if and when the local situation and public health measures allow.

Thus, the MSSD, MBHTE and other concerned ministries are recommended to adopt the following:

- (1) Education Learning Continuity such as learning materials, tools (tablets, laptops, smartphones, etc.), guidance, resources such as providing free books and modules, as well as information for COVID-19 prevention and controls shall be provided to the children especially in the remote areas. This is needed by the guidance of the teachers and parents in supporting their children in home-based or distance learning. Disadvantaged children such as orphans, IDPs, poor and needy shall be prioritized by this program;
- (2) Increased Educational assistance and give more scholarship grants to the deserving children especially in the remote areas that shall be determined through a wide, inclusive and fair assessment. Orphans and disadvantaged children shall be one of the priorities for educational assistance to make sure that they still have access to education especially in this time of pandemic;

(3) Mental health and psychosocial support that is provided to the children and their families. It is important for families to develop emotional and social promote physical psychological well-being from home, through the adoption of healthy practices and lifestyles. This category features resources on mental health and psychosocial support, guidance on how to support young children to face changes, advice on how to protect the mental health of families in the face of the coronavirus disease, and strategies for teenagers on how to protect their mental health during the coronavirus outbreak.

POLICY BRIEF ON ORPHANS AND CHILDREN:

RECOMMENDATIONS FOR STRENGTHENING THE SPECIAL COMMITTEE FOR THE PROTECTION OF CHILDREN (SCPC) IN THE REGION

Our children have the right to be protected from all forms of abuse, neglect, exploitation and violence. This right to protection has been clearly laid out in the Convention on the Rights of the Child (CRC) adopted by the United Nations General Assembly on 20 November 1989. This is also emphasized in accordance with Section 14 of the Republic Act No. 11054 states that "the Bangsamoro Government shall respect, protect, and promote the rights of children, especially orphans of tender age."

They shall be protected from exploitation, abuse, or discrimination. Their education and development, both physical and mental, shall be fully addressed, and the policy of protection also stressed in Article XV, Section 3 of the 1987 Constitution provides that "the State shall defend the rights of children to assistance, including proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty, exploitation and other conditions prejudicial to their development".

According to the Special Committee for the Protection of Children [SCPC] (2006), a growing number of Filipino children today especially in this time of pandemic find themselves in various situations of abuse, neglect, exploitation and violence brought about by various factors including but not limited to:

- (a) broken families:
- (b) increasing school drop-out rate;
- (c) inadequate basic social services;
- (d) weak and inconsistent enforcement of child protection laws;
- (e) growing unemployment and underemployment;
- (f) inequitable distribution of wealth, income and opportunities;

(g) continuing impoverishment and marginalization of millions of Filipino families; (h) intermittent armed conflict particularly in Mindanao; (i) rising materialistic and consumerist expectations; and (j) deteriorating moral values as demonstrated in the "commodification" of human sexuality perpetuated through mass media, among others.

As an expression of that commitment, our Legislature enacted in 1992 Republic Act No. 7610, "An Act Providing Stronger Deterrence and Special Protection against Child Abuse, **Exploitation** and Discrimination". Thereafter, the Committee for the Special Protection of Children (CSPC) was created in 1995 through Executive Order No. 275 to monitor enforcement of RA 7610.

The Committee has been further strengthened through the issuance in 2011 of Executive Order No. 53 by President Benigno Simeon Aquino III by adding more key and relevant member agencies and sharpening its focus on the legal and judicial protection of children.

The CSPC – which is chaired by the Department of Justice (DOJ) and cochaired by the Department of Social Welfare and Development (DSWD) – is tasked to initiate and coordinate the formulation and implementation of a Comprehensive Program on Child Protection (CPCP) (SCPC, 2012). Moreover, a protective and caring environment for children must be prioritized by the government, and must be the concern of all actors at various levels of society.

Thus, the Bangsamoro Government together with the appropriate ministries and other line agencies in collaboration with the Local Government Units, Non-Government Organizations (NGOs), and other institutions in the region are recommended to adopt the following:

- (1) Strengthening the action forces of government's commitment and capacity to fulfill their mandates in children's rights to protection;
- (2) Crafting policies that would institutionalize the Comprehensive support program in the enactment and enforcement of child protection laws consistent with the CRC; such programs should include but not limited to equipping children with knowledge, life skills and capacity for meaningful and effective participation, and building capacities of parents, teachers, religious leaders, social workers, health workers, law enforcers, prosecutors, judges, etc. to recognize and respond to abuse, exploitation and violence;
- (3) Strengthening the Local Council for the Protection of Children (LCPC) provincial, municipal, city and barangay, particularly the Barangay Councils for the Protection of Children (BCPL). The role of Local Government Units (LGUs) should also be highlighted, coordinated, and sustained for the actions of the child care and protection;
- (4) There is a need for the Bangsamoro Government coordinated with the appropriate ministries and offices to establish an effective monitoring, reporting and coordination mechanisms for the enforcement of RA 7610, and the multilevel child protection system in the Region. More importantly, under a protective Environment, children at risk are prevented from becoming victims of various forms of abuse, exploitation and violence by facilitating their effective access to basic social services such as health and nutrition as well as opportunities for basic education, life skills education, and vocational training, among others.

Sa mga pagkakataong wala ang magulang o walang kamag-anak na maaaring gampanan ang tungkolin ng kanyang namatay na mga magulang, sino ang dapat tumugon sa kanilang mga daing o panawagan? Dito kinakailangan ang intervention ng ating pamahalaan lalong-lalo na ang BARMM Government.

Sa ating bagong gobyerno ng tinaguriang "BARMM", dapat magkaroon ng pagkakataon ang bawat sector na marinig ang kanilang hinanaing upang malaman at matugunan ng Pamahalaan. Ito ay kinakailangan para sa paggawa ng mga tumutugong proyekto at batas.

Ang isa sa mga pangunahing prayoridad ng aking tanggapan ay ang ating mga bata at mga batang ulila (Orphans and Children). Pinapangunahan ng ating Opisina kasama ang ating mga partners ang maraming mga hakbang sa paglilingkod sa ating mga ulila at bata tulad ng "Siyap Ko Wata-Ilo Outreach Program" sa home-based at center-based na mga orphanage sa loob at sa labas ng rehiyon, "Siyap ko mga Wata" at "Siyap ko mga Toril". Tayo ay naniniwala na sa pamamagitan ng ating pakikilahok at pakikipagtulungan, maari nating mapabuti ang ating mga serbisyo at mga hangarin upang matugunan ang mga alalahanin ng mga batang ulila sa pamamagitan ng pagbibigay ng konkretong programa at mas epektibong batas.

Kamakailan ay nagsagawa tayo ng CARE FOR ORPHANS PUBLIC CONSULTATION IN AID OF LEGISLATION sa buong rehiyon kasama ang ating partner na "The Asia Foundation". Ang unang konsultasyon ay ginanap sa Lanao del sur noong Marso 20, 2021, at sa Maguindanao naman noong Mayo 31, 2021, at sa lalawigan ng BASULTA nong buwan ng Hunyo at Hulyo. Ito ang aming hakbang upang mapalawak ang maabot ng aming mga konsultasyon upang makakuha ng isang mas mahusay na larawan ng sitwasyon ng mga ulila sa buong Rehiyon. Nais naming marinig mula sa kanila ang iba't ibang mga isyu, problema at hamon ng mga ulila direkta mula sa mga stakeholder, partners, indibidwal o institusyong sumusuporta sa kanila.

Base sa lumabas sa ating mga konsultasyon, ang mga pangunahing isyu at mga problema ay ang:

- (1)Kakulangan ng konkretong datos tungkol sa mga ulila sa loob ng ating rehiyon,
- (2)Ang mga problema at suliranin tungkol sa pamantayan ng mga ipinapatayong toril or madrasa institutions,
- (3) Limitadong suportang pinansyal at tulong sa mga ulila tulad ng pag-access sa edukasyon at serbisyong pangkalusugan,
- (4)Kakulangan ng suporta sa pangangasiwa ng mga ulilang nakabase sa bahay at yong nasa Toril learning school o Madrasah at
- (5) Ang mga isyu patungkol sa kanilang seguridad at hustisya.

Ayon sa pag-aaral mula sa "Children of War: A Rapid Needs Assessment of the Orphans in Muslim Mindanao" na suportado ng The Asia Foundation (2020), kasalukuyang walang mga orphanage o tirahan na accredited ng DSWD sa Bangsamoro. Sa halip, maraming mga ulilang Muslim mula sa Mindanao ang natulongan ng DSWD noon sa pag proseso ng kanilang mga papelis ang madalas na ipinapadala sa mga orphanage center sa Maynila. Ang suliranin na ito ay dapat isa sa prayoridad na kinakailangang tugunan ng ating pamahalaan. Sa pamamagitan ng pagpapatayo ng mga orphanage center ang pagbibigay kanila ng suporta sa makakapagbigay ang Pamahalaang Bangsamoro ng mas higit na positibong epekto sa buhay ng mga batang ulila.

lto ay ilan lamang sa mga rekomendasyon mula sa ating konsultasyon: (1)magdisenyo ng holistic inclusive isang at na komprehensibong programa para sa balo at mga ulila, tulong sa pinansyal at suporta sa mga bata at sa institusyon tulad ng mga Toril at Madrasa, (2)Ang mga bata kinakailangang magkaroon proteksyon mula sa pang-aabuso, (3)Siguradohing ligtas sa anumang kapabayaan at karahasan ang mga bata at (4) palawakin ang serbisyong pangkalusugan at edukasyon, pagbibigay oportunidad ng pangkabuhayan sa mga pamilya o tagapag-alaga sa mga bata upang mapabuti ang kanilang kondisyon at pamumuhay. (5) at ang maigting na pagpapatupad ng mga patungkol sa mga Karapatan ng mga bata.

SPONSORSHIP SPEECH ON BANGSAMORO ORPHANAGE ACT 2020

December 21, 2021



Mr. Speaker, Members of Parliament, and distinguished colleagues: Assalaamo Alaykom Warahmatullahi Wabarakatuh!

Today, I have the honor to seek approval of Proposed Bill No. 71, entitled AN ACT INSTITUTIONALIZING SUPPORT TO THE WELFARE AND CARE FOR ORPHANS BY ESTABLISHING BANGSAMORO ORPHANAGES IN THE REGION, AND PROVIDING FUNDS THEREOF filed on November 9, 2020.

I am standing here today as a Member of Parliament, a mother, a Moro, and an advocate for children's rights with an immense concern for the well-being of our future generation.

In Islam, an orphan is the child or the minor who, by the will of Allah, has no parents or has just one parent. In Islam, the absence of a father either by death or abandonment or any other reason results in the child becoming an orphan. The child remains an orphan till he/she reaches the age of maturity or puberty. Because orphans are minors, they are physically weak, disadvantaged in society, and often suffer from poverty. Many are children of shaheed, or martyrs in the service of the Moro revolutionary fronts.

For a child who has lost a parent, life is filled with hardships. In the absence of early child and development support, the orphaned child is one of those most vulnerable to poverty, radicalization, and criminality. Some orphaned children are blessed by being adopted by their relatives, but some are not provided with enough care. Meanwhile, there are those supported by institutions, however in truth, only a few are accommodated due to limited resources.

The sad reality is that if foster parents, social workers, or institutions are not there to provide what they need, no one will. This is the time for the government to step in. Under the principle of parens patriae, the government should stand in as the parents and caregivers of the orphaned child.

As the new government raises the so-called "BARMM", we believe that every sector should have the opportunity to be heard. Orphans are among the most vulnerable sectors. On top of that, they do not have sufficient budget, programs, projects, and policies for them.

According to the research study by The Asia Foundation in 2020, entitled "Children of War", there are currently no Department of Social Welfare and Development (DSWD) or MSSD -accredited orphanages or shelters in the Bangsamoro region, some reasons is that they did not meet the requirements given to them, that's why, many Muslim orphans are often sent to orphanages in Manila.

Moreover, respondents across the region noted that being unattended, ignored, and unloved leaves orphans vulnerable to radicalization and co-option by violent extremist groups. Without proper assessment and processing of their emotions, orphans may grow up believing resolving issues through violence is normal.

Mr. Speaker and Members of Parliament,

This bill seeks to institutionalize support for the welfare and care of orphans in the Bangsamoro region by establishing a system of accredited Bangsamoro Orphanages within each province throughout the region which will help alleviate the condition of every orphan and to provide them with the opportunity to live a fulfilled life. Moreover, it seeks to create a system that will determine the qualified beneficiaries and to monitor and evaluate the proper provision of this Act.

It has been months of efforts from our office to come up with this bill. Our office conducted series of CARE FOR ORPHANS PUBLIC CONSULTATIONS IN AID OF LEGISLATIONS IN THE WHOLE REGION in partnership with The Asia Foundation. Our first consultations held in Lanao is on March 20, 2021, in Maguindanao and Cotabato on May 31, 2021, and to the provinces of Basilan, Sulu, Tawi-Tawi in the months of June and July. The consultations had focused on the various issues and concerns of orphans, as well as the stakeholders who took care of them, and participated by different sectors, stakeholders. individuals, institutions, offices/ministries, and various organizations.

They provided inputs and recommendations addressed to the Bangsamoro Government, and to our Proposed BTA Parliament Bill No. 71, or the "Bangsamoro Orphanage Act 2020", where the participants gave their comments, inputs, and recommendations for the improvement of the bill. Our participants and many stakeholders signed the manifestation of support for the immediate passage of this Bill.

Some of the major issues and concerns that were raised from these consultations is that there was no concrete data about orphans in the region; there are also challenges with respect to the subpar standard of centers (*Toril/Madrasa* Institutions); Limited financial support and assistance to the orphans, including home-based, center-based, and displaced orphans; Lack of access to education and health services; Lack of support and supervision among the orphans in the home-based and center-based institutions (*toril* learning schools and madrasah); vulnerable to recruitment and radicalization; and issues on security and justice, prone to abuse.

I will now highlight the main features that we proposed from the Bill

• There is hereby created a system which shall lead the creation of a credible mechanism to determine the eligible beneficiaries and shall create the appropriate model for the orphanages in the respective community. It is also its mandate to come up with a comprehensive monitoring system to address the needs of orphaned minors in the respective community. It shall include, but not be limited to, coming up with updated data on the number, location, and personal profile of orphaned minors in their communities, respective developing appropriate models of orphanages in the respective community, and monitoring orphaned minors in the orphanages.

- The bill also seeks to develop and create comprehensive support program that is institutionalized as a mechanism to provide social welfare and care for orphans in the orphanages by the Bangsamoro Government through its agencies. The implementing programs shall include but is not limited to: (i) Basic needs; (ii) Physical safety and security; (iii) Socioeconomic needs; (iv) Educational needs; (v) Emotional and spiritual needs, and (vi) Access to justice.
- The bill includes the constituent LGUs in the Bangsamoro Region are mandated to develop a monitoring and evaluating system over the orphanages found within their jurisdiction, and to assist them with accreditation.
- There shall be a managing committee in charge of the management of the established Bangsamoro Orphanages and shall require program requirements and transparency.

Mr. Speaker and Members of Parliament,

To pass this bill also means to implement the mandate of Bangsamoro Organic Law. It is hereby declared the policy of the Bangsamoro Government to respect, protect and promote the rights of children, especially orphans of tender age. They shall be protected exploitation. abuse. discrimination. Their education and development, both physical and mental, shall be protected from exploitation, abuse, or discrimination. Their education and development, both physical and mental shall be fully addressed under Section 14, Article IX of Republic Act 11054.



Bangsamoro policies and programs shall take into utmost consideration the best interest of children, and promote and protect the rights of children, youth, and adolescents, including their survival and development. The Bangsamoro Government and its constituent local government units shall provide for adequate funding and effective mechanisms for the implementation of this policy.

Building orphanage centers (Baytul Yatim) will help alleviate the condition of every orphan. Orphans are often sent to this institution as a way of relieving a family with very little income or limited capacity to meet the needs of the child. Orphans in orphanages should be given a safe environment to grow, with a good place to sleep, adequate food and proper schooling, and also visited their families often, this way to help them grasp their rights as institutionalizing individuals. By orphanages that are supported by the Bangsamoro Government, we will have more impact on the lives of these orphaned children and reach those more in providing services with quality care.

We all know how much our orphans are being valued and cared by our religion. Besides, our Prophet Mohammad (S.A.W) is an orphan himself, and the topic on orphans has been mentioned for over twenty times in the Qur'an and is also signified by the Hadith and Sunnah of the Prophet (S.A.W) countlessly.

As per the Hadith of the Prophet Mohammad (S.A.W) mentioned in Saheeh Al-Bukhari: "I and the caretaker of the Orphan will enter Paradise together like this, (raising his forefinger and middle finger jointly, leaving no space in between.)"

When we help orphan children raised in a healthy and loving environment, they grow up to be responsible individual, and there will be less crime, less deprived children and less out-of-school children. Our children are the most valuable resource in our country and its best hope for the future, before they can be responsible and ideal youth, we need to guide and mold them in their early years to help them become the best version of their selves. Our children's future is worth every sacrifice; by helping them, we are helping our future.

It is for these reasons that the early approval of this bill is earnestly sought.

Mr. Speaker and Members of Parliament,

Every Bangsamoro Child deserves to be protected.

It is finally time to establish orphanages in the Bangsamoro Autonomous Region In Muslim Mindanao (BARMM) and to provide support to our institutions housing orphans especially for our children of *shaheed* or *martyrs* in the service of the Moro Revolutionary Fronts.

And So,

I humbly recommend to the Bangsamoro Transition Authority to adopt this bill and to support the quick passage of *Bta Parliament No.* 71 Or The Bangsamoro Orphanage Act 2020, for the sake of our children and orphans in the BARMM.

Let us take a look at our 'Modern-Day Heroes' who selflessly perform their job during the COVID-19 pandemic despite the hardships and health risks.

Meet Shahanie B. Baulo, or "Shanie" for short, 22 years old, a field staff nurse. She is a member of the COVID-19 Surveillance Team - City Health Office (CHO) Marawi City. She recently passed the Licensure exam last year, 2019, and went straight for a job at the CHO because she want to serve the Bangsamoro people especially those in the periphery, the poor and the needy.

She faces the everyday challenges of a health frontliner- physically and mentally exhausted, experiencing the feeling of fear, anger, anguish, panic and anxiety. The fear for the unknown, the anger over the unseen enemy taking away innocent lives, the sadness over the rapidly increasing mortality and morbidity rates, the panic attacks felt every time the 'what ifs' anxiety comes.

Shanie confides that every night before sleep, she feels a struggle to find peace and calm.

With perseverance, Shanie overcomes the challenges through prayer and motivation from her family. "Continue to chase your passion and dreams with a purpose. Do it for yourself and for the people who needs you.

Always give a hand without expectations. Be a role model to the people, in that way you will be remembered." Shanie says.

As long as her family supports her choice to work in the frontlines, Shanie continues to feel inspired. She also knows that it is through her work that she will be able to protect her family and all communities in Marawi City and Lanao del Sur.

Health workers are on the frontline in the fight against the new Corona Virus, they carry enormous task at work and face the fear of bringing the virus home to their families. Our ability to help the helpers is our main significant contribution for them, and mainly for us.

We need a whole-of-society resolve that we will not let our frontline health soldiers become patients.

Team MP Maisara is one with supporting and recognizing the heroism of our healthcare workers, supporting them with adequate *Personal Protective Equipment* (PPE) and masks could help them halt the spread of the virus. We need to be determined to explore every avenue to ensure all the possible support for the health workers.

CALL FOR BANGSAMORO ORPHANAGES

"The story of our children is the story of our future."

This is a story of a child roaming outside because he doesn't have a place to stay, a child without parental care or he may live with a relative or a neighbor but could not take care for him, a child who could be forced to work to earn a living and even for his family, a child who is being unattended and ignored that could lead him to radicalization and co-option by violent extremist groups, and a child who could be deprived of basic services including access to education and health services.

These are more closely associated with a child who lost his parents or just one parent. Without love and care of the parents, life is filled with hardships. In the absence of ample support, the orphaned children is one of the most vulnerable as they might end up engaging in criminal acts, they may grow up believing resolving issues by violence, they could die of starvation or malnutrition, they could be at risk and vulnerable to recruitment by the armed and extremist groups, they could do harm to others and impact the world in a negative way. But in some cases, orphaned children seek out warmth and love from other families or relatives but many of them end up living on the street.

Some orphaned children are being supported by family network or support institutions (both home-based and in-center) also exist to provide assistance, often in the form of sadaqah (voluntary giving or charity) or zakat (tithing). However, most respondents only receive support from extended family members for the first year, after two or three years, this support declines. As the cases of support institutions (both home-based and incenter), the number of orphans that can be provided support is limited by available resources.[1]

According to the study of The Asia Foundation (2020) there are no DSWD-accredited orphanages or shelters in the Bangsamoro. Instead, many Muslim orphans processed by DSWD in Mindanao are often sent to orphanages in Manila. Other private charitable organizations focusing on children and orphans from the BARMM have arisen in areas with a sizeable Muslim diaspora, such as Maharlika Village in Taguig, Culiat in Quezon City, Quiapo, Manila, and Baguio City. These places are used as educational hubs, not only by ethnic Bangsamoros, but also those considered *Balik-Islam*, or reverts to Islam.

However, some respondents noted that there are cases where orphans are perceived as additional burden, particularly when they are taken in by distant relatives who are forced to take them in. This can lead to discrimination or abuses when it is not their choice to take care of the orphans but are obligated by cultural and religious norms. Some respondents described caretaker relatives who send their biological children to school but do not extend the same privilege to the orphans (purportedly due to limited resources). Others give jobs to orphans in the guise of providing employment, but these roles can be unpaid, low-paying, or unpleasant (as househelp and/or various forms of hard labor such as digging ditches, latrines, or graves).

'ORPHAN CARE CENTER 'because every child deserves a chance...

Explore appropriate models for orphanage centers per town to cater orphans with no guardians for in-house care, including 'village' type settlements where orphans and widows can be together, and training of personnel to provide appropriate care. Education is a primary need, incentive, and goal for most respondents, alongside access to jobs. However, respondents identified at least five common needs and aspirations of orphans that should be addressed by a comprehensive support program: (i) Physical safety and security; (ii) Socio-economic needs; (iii) Educational needs; (iv) Emotional and spiritual needs, and (v) Access to justice (The Asia Foundation, 2020).

Building orphanage centers such as *Baytul Yatim* will help alleviate the condition of every orphan. Orphans are often sent to this institution as a way of relieving a family with very little income or limited capacity to meet the needs of the child. Orphans in orphanages should be given a safe environment to grow, with a good place to sleep, adequate food and proper schooling, and visited their families often, this way to help them grasp their rights as individuals. EDUCATION, MY ONLY HOPE

"During Marawi Siege, we lost our home and a small sari-sari store, our only earnings. After Marawi Siege, we lost our father who has been terribly sick because of paralysis and a trauma brought by the siege and now a pandemic; I couldn't afford to lose my education too." Sittie parrated.

Hopeful as she is, Sittie stated how important to her is the education. "Education is my only hope, we lost everything from Marawi Siege and now I need to finish my study to support my family." She added.

In this time of pandemic, we are experiencing global crisis, as much as the students want to continue to school but due to lack of financial resources and capacity to meet the new normal requirements, most of them are being forced to stop.

"It is almost three (3) years since the Marawi Siege happened, yet still remained in this temporary shelter. My mother is old and sick, she has no job. I, together with my five siblings, was just supported by the generous relatives and sometimes through sadaqah (voluntary giving) from our neighbor." Sittie said.

The coronavirus pandemic has been exposing us that education 'is only' for those who can afford. It is one of the problems of the government that needs to be resolved; to make education accessible to all under any circumstances.



"Education is my top priority since then because it was the dream of my father but due to this circumstance, though it's painful for me, I need to stop schooling for a while and start looking for a job instead so that I could pay bills and support my family." she added.

While we recognized the importance of continuity learning, the government must address the issues/gaps and challenges that brought by the new normal education, explore more appropriate model that is necessary to resolve the status quo and make a long-term solution to ensure that our education is accessible by anyone under any circumstances, so that we could ascertain that "No Bangsamoro Child left behind" in our region.

EARLY LEARNERS AT BLENDED LEARNING- ARE THEY READY?



"We are not ready for a Blended Learning; but we are now preparing for a Modular Distance Learning in our school." Rahma, a teacher from Marawi City said. "Moreover, we also can't afford to provide online learning since majority of our learners and teachers are residing in the remote areas. Slow internet connection and scarcity of technological devices are the primary problems." She argued.

"It's quite a challenge for us teachers that we need to make modules in accordance to the working activity of our pupils and it should be understood by their parents." A private teacher from Marawi City narrated how hard their adjustments in preparing for the opening of the class. The school is part of the most affected area during Marawi Siege, they transferred to Marantao, and occupied a small building of abandoned Madrasa for free, it is solely from the parents' payments were the expenses of the school came from and now since their main problem is the low rate of their enrollees because of pandemic; they experienced limited financial resources and capacity to adjust for this new normal Education. "For the sake of our learners, we continued to work even though we don't have salaries." She added.

This situation represents many schools in Lanao del sur especially in Marawi City, as they struggled to meet the new normal education requirements while not compromising the health of their students. Both learners and teachers are new to this kind of Learning Modalities. Teacher from Marawi city narrated how blended learning is a very tough challenge to both teachers and early-learners especially in remote areas.

"Early learners will have a hard time adapting this so called blended learning, especially that of combination of modular and online education." Miah, a primary school teacher from Marawi City said.

"In terms of modular, we all know that early learners especially kindergarten pupils have a very short attention span. So, how can they learn all the content of their module if they're not with their teachers (absence of face-to-face education)? They're fortunate if their parents are not that busy and will voluntary teach them the whole content of their module like how their pre-school teachers do." She added.

"Another thing is that in terms of online education, it's more difficult to apply here in our locality, knowing that our internet connection here is very poor. Not all the pupils and the teachers have enough access to internet, and even if for some pupils having good access to internet, we are not really sure if they're willing to participate in their online class because most of them prefer doing online games than listening to online classes." She argued.

As the global COVID-19 pandemic continues to unfold, young children will always be one of the most vulnerable, this time with full of challengesalso offers us some opportunities. It's time for us to not just resort to a single option but to have multiple plans. However, this blended learning may be implemented for early learners as long as their parents and caregivers are willing to assist and guide them as their teachers at home. The parents and educators will have a big role in this time of pandemic, they need to support and help one another in preparing for our children in education that needs a lot of effort and apt planning; we need always to bear in mind that our children's future is worth every sacrifice.

Isinilang si Baby Mina ngayong taon, ika-14 apat ng Hulyo sa kanilang temporary shelter sa Boganga, Marawi City. Tulad ng lahat ng mga batang bakwit, walang katiyakan ang kanyang kinabukasan.


Subalit pangarap ng kanyang nanay na mabigyan ng magandang buhay ang kanyang mga anak kahit hindi na nila masisilayan ang kanilang ama dahil mag-a-apat na buwan na itong namatay. Ang kanyang ama ay nagtrabaho noon sa Manila bilang Taxi driver.

Si Baby Mina at ang kanyang nanay at apat na kapatid ay umaasa lamang sa pinamimigay na mga tira o sobra mula sa relief assistance. Yung tira lamang ang nakukuha nila dahil sila ay kasama sa "unrecognized occupants" ng shelter na nakikitira rin lamang doon. Hirap man sa buhay sa pagiging bakwit nananatili pa rin ang bayanihan ng mga kasama nila sa shelter. Sila ay nagtulungan at nag-ambagambag noon sa pagsilang ni Baby Mina.

Isa lamang si Baby Mina sa maraming mga sanggol na bakwit na isinilang sa temporary shelter hahamon sa buhay dahil sa pangyayari noong "Marawi Siege." Sa ngayon, ang tanging pangarap ng nanay ni Baby Mina ay makabalik at makapag-simula muli sa kanilang lugar sa Marinaut. Ang Marinaut ay napabilang sa "Most Affected Area" noong Marawi Siege. Pangarap ng nanay ni Baby Mina na lumaki ang kanyang mga anak na mapayapa, may pangarap, at may magandang kinabukasan. Higit sa lahat, ay hindi lumaking mga bakwit pa rin.

"Hindi man nila masisilayan ang kanilang ama sa kanilang paglaki, ang aking pangarap ay mabigyan sila ng pagkakataon na masilayan ang lugar at tahanan na kung saan kami namuhay noon— sa lupang sinilangan ng kanilang ama," wika ng nanay ni Baby Mina.

LIFE OF AN ORPHAN IN TORIL



Five-year-old boy Asnawe narrated how difficult his life became when his father died years ago. Together with his three siblings, they relied on their aunts who are farmers for support as their mother has no job.

According to Asnawe, when there is no food to eat, his mother would ask him to borrow money from the neighbors in order to buy rice at the store.

However, there are times when no one would lend a hand. During such cases, he would just play outside and entertain himself to forget the hunger.

He would return home with stomach ache and his mother would tell him and his siblings to just sleep in order to forget the hunger. Despite hardship, Asnawe remains hopeful. His dream is to become a *hafidh* (a person who memorized the Qur'an) in order to ensure that his family members enters Janna (Heaven).

He is currently in *Qaeedah* (Level 1) in the Toril and strives hard in memorizing the Qur'an. He said that, in the beginning, living in the toril was hard, but he chose to stay in order to lessen the burden of his family and to make his dream come true.

"Mab'b'lag ako saki ome ago so mga pagare akn, na di ta di makatigr ka kagya aya akn mapipikir na so singanin akn a makapasad mangadi agu mbaloy a hafidh (I'm away from my mother and siblings but I have to endure the pain because of my dream to finish my studies and ultimately become a Hafidh)," Asnawe said.

He is inspired to finish his studies not only because of the company of his classmates but also because it was the dream of his father (to become a *hafidh*).

SUMMARY

Children and young people with the absence of their parents either by death or abandonment are clearly vulnerable groups and results in the child becoming an orphan; they are physically weak in the society and are mostly challenged by poverty. The sad reality is that if foster parents, social workers, or institutions are not there to provide what they need, no one will. This is the time for the government to step in. Under the principle of *Parens Patriae*, the government should stand in as the parents and caregivers of these vulnerable children.

SIYAP KO MGA WATA IN AID OF LEGISLATIONS aims to promote and protect the rights and welfare of the children through various programs and activities, and to capture the situations and gather data that can be the identification of key topics to consider in aid of legislation.

We conducted CARE FOR ORPHANS PUBLIC CONSULTATIONS IN AID OF LEGISLATIONS IN THE WHOLE REGION in partnership with The Asia Foundation. The consultations focused on the various issues and concerns of orphans, as well as the stakeholders who took care of them, and participated by different sectors, stakeholders, individuals, institutions, offices/ministries, and various organizations. They provided inputs and recommendations addressed to the Bangsamoro Government, and to our Proposed BTA Parliament Bill No. 71, or the "Bangsamoro Orphanage Act 2020", which would establish and institutionalized support to our orphans and the participants gave their comments, inputs, and recommendations for the improvement of the bill. Our participants and many stakeholders signed the manifestation of support for the immediate passage of this Bill.

As we continue to support and advocate for children's rights, we are working hand in hand to make sure that our children should be prioritized and included in the programs, budgets, and activities of the Government to improve their lives and welfare. We give importance to them because they are the hope of the next generation. Let us continue to support in creating a better world for our children, making a better place and a safe environment for them to take care of and pass on to future generations.
